
1. Call to order, roll call, and determination of quorum.

Due to time constraints, public comments will be limited to three (3) minutes per speaker. No comments or action can be made by the Board during this period. Any item requiring action will be placed on the agenda for the next Board Meeting.

11. Adjourn into Executive Session as allowed by Texas Government Code Section 551.071, if requested.
12. Reconvene into Public Session. Discussion and possible action regarding matters discussed in Executive Session.

No final action, decision, or vote will be taken on any matter in the executive/closed session.
